Official Equestrian Canada Statement

The Glanbrook CADORA Bronze and Silver competitions are sanctioned as Bronze and Silver competition members of Equestrian Canada (EC), c/o House of Sport 2451 Riverside Drive, Ottawa, Ontario K1H 7X7 and are governed by the [Rules of EC](#) (A602.1).

Every class offered herein is covered by the rules and specifications of the current rules of EC and will be held and judged in accordance with the EC Rule Book. (A602.2) Refer to Section A General Regulations and Section E Dressage and Para-Dressage.

Any athlete an EC sanctioned competition may be selected for human anti-doping as outlined in the Canadian Anti-Doping Program (CADP) and administered by Sport Integrity Canada. Please see EC General Regulations Section A - Appendix A1, Policy on Human Medications for details. (A602.6)

Per Article A801, every entry at an EC-sanctioned competition shall constitute an agreement by the person(s) responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horse shall be subject to the EC constitution and all rules of EC and any additional rules set by the competition. It is the responsibility of all individuals participating in any capacity in EC-sanctioned competitions to be knowledgeable regarding the EC constitution and the applicable rules of EC and the additional rules, if any, imposed by the competition. Do not participate in this EC-sanctioned competition in any capacity if you do not consent to be bound by the constitution and rules of EC and any additional rules imposed by the competition. (A602.7)

In determining whether conduct or treatment is cruel, abusive or inhumane, the standard to be applied will be the conduct or treatment expected of a reasonable person who is informed and experienced in equine training and exhibition procedures.

Individuals who interact with horses must also adhere to EC's policies as they relate to horse welfare.

Equestrian Canada Statement of Principles – Horse Welfare (Section A)

1. Equestrian Canada (EC) is committed to fostering a safe and inclusive environment for all participants that is free from Abuse. The purpose of this Policy is to stress the importance of that commitment by educating Individuals and the public about Horse Abuse, outlining how EC will work to prevent Horse Abuse, and how such Abuse or suspected Abuse can be reported to and addressed by EC.
2. EC requires that all Individuals adhere to this Code of Conduct and acknowledge and accept that the welfare of the Horse must always be paramount and must never be subordinated to competitive or commercial influences.
3. Section A Horse Welfare rules apply to all disciplines and all Section Rule Books. Rule exceptions in other Sections that contravene Section A Horse Welfare rules are not permitted and will not be approved.
4. EC is committed to:
 - a. recognizing Horses as sentient beings, defined by the ability to feel, perceive or experience subjectively. (ie. the animal is not only capable of feeling pain and distress but also can have positive psychological experiences, such as comfort, pleasure or interest that are appropriate to its species, environment and circumstances). To state

that animals are sentient accepts that they can experience positive and negative emotions.

- b. b. upholding the welfare of the Horse, regardless of value and performance level, as the primary priority regardless of competitive commitments, expectations, or commercial influences;
- c. requiring the Horse to be treated with the highest level of care, compassion, respect, and empathy;
- d. requiring that no Horse be subjected to Abuse (ref: Rules of Equestrian Canada, Section A General Regulations, Article A517) or Distress;
- e. ensuring that all Individuals accept and implement, at a minimum, the requirements within the National Farm Animal Care Council Equine Code of Practice;
- f. ongoing support for scientific studies of animal-based indicators of pain, Page 2 2026 Rules of Equestrian Canada Section A Distress, and/or compromised welfare;
- g. increasing education and awareness for the evolution of best management and equine husbandry practices;
- h. requiring Individuals to know and follow the EC rules and implement industry regulations in all competitions; and,
- i. reviewing, revising, and developing competition rules and regulations that protect the welfare of the horse

The competition will begin at approximately 8:30 a.m. Show grounds will be open 90 minutes before the start of the competition. Ride times are available through CompeteEasy, Glanbrook CADORA's Facebook Group and website.

First Aid:

A certified **First Aid service** will be available on-site.

On-Call for equine emergencies:

[Troy Equine Services](#) and [Bennett Equine Veterinary Services](#) will be on-call for equine veterinary emergencies and Tracy Ferguson will be the on-call farrier.

Stabling:

A limited number of stalls will be available and must be paid in advance with a refundable deposit for clean-out. **No overnight stabling available.**

Shavings may be ordered and must be paid for **in advance** with entry. No additional shavings available for purchase on show day.

Classes Offered

English Dressage Classes:

EC National Dressage tests are offered. The Introductory Tests are 2023 USDF tests (~~offered in the Bronze classes~~), Training through Fourth Level Tests are 2023 USEF tests, the FEI Prix St. George, Intermediate I (offered in the Silver classes), and the Para Dressage tests (offered at both Bronze and Silver) and the Freestyle tests are available through the EC website at <https://www.equestrian.ca/sport/dressage/tests>

***NEW FOR 2026 - Western Dressage Classes:**

Western-Style Dressage will be offered in the Bronze show, but are not rated for EC awards (Article A503.3). The Western Dressage tests are WDAA tests and will be required to follow the WSDAC rulebook; however, all other EC rules such as those pertaining to memberships, sport licenses, equine medication control, EC National Passports/FEI Passports/Horse Recordings and entry status will apply (A503.5) Tests are available from the Western Style Dressage Association of Canada at <https://westernstyledressage.ca/>

Para Dressage:

All EC Para Dressage Tests are available upon request for both Bronze and Silver entries.

Junior Riders:

Separate Junior classes will be offered for all classes and levels of both Bronze and Silver shows.

Adult Amateur and Open Riders:

Adult Amateur and Open classes are offered for all classes and levels of both Bronze and Silver shows. Entries of Adult Amateurs and Open riders are not separated into separate classes.

Ring Size:

All tests (Bronze and Silver competition) will be ridden in a 20x60 m ring, except Grades I, II and III Para-Dressage Tests which will be ridden in a 20x40 ring.

Memberships, Licencing, Horse Recordings and Coaching

REQUIRED - Ontario Equestrian (OE) Membership and Equestrian Canada (EC) Sport Licence:

- OE membership and EC Sport Licences are required for the horse owner, rider, and Person Responsible.
- All the above membership forms can be found on the OE and EC websites.
- Licence status will be checked prior to the competition and no rider, coach or owner will be allowed to compete without appropriate licences. Fines can be levied by Equestrian Canada for any individuals or competitions that allow individuals to compete without the proper licence.
- **The rider, horse owner, and Person Responsible** entering a **Bronze** competition must be members of Ontario Equestrian (OE) and hold an EC Bronze Licence (minimum).
- **The rider, horse owner, and Person Responsible** entering a **Silver** competition must be members of OE and hold an EC Silver Licence (minimum).
- **Amateur Status:** If you are competing as an Amateur rider, you must have the Amateur Status added to your EC licence. OE charges an additional fee for Amateur Status. If your OE licence does not reflect Amateur Status, you may show as an Open competitor.
- **Temporary Sports Licence:** Temporary sports licences are now discontinued at competitions. All riders, owners and coaches must possess a valid EC Sport License to participate in events
- **EC Horse Recording:** Horses in **Silver** competition must have an EC Horse Recording and have paid the current EC Horse Recording annual Activation Fee to compete (See A403). Foreign entries must sign an affidavit. (See A404). (A602.4). The Horse Recording must be provided to the Competition Secretary before a horse will be allowed to compete. For information and application, contact 1-613-287-1515 or [EC Horse Recordings](#). EC Horse Recordings are not required for **Bronze** competition.
- **Temporary Horse Registrations:** Temporary Horse Registrations have been discontinued. All horses must have a Horse Recording where level and division require.

Glanbrook Cadora (Optional):

Glanbrook CADORA memberships are not required to enter. In order to be eligible for member discounts on entry fees, the rider must either purchase a membership with the entry, or already be a member in good standing when entries are submitted. To be eligible for Glanbrook CADORA year-end awards, the rider must be a member in good standing by July 1st of the current year. To join, you may join directly on the show entry form at www.competeeasy.com or you may access the membership form on our website at <https://www.glanbrookdressage.ca/membership>

Ontario Dressage (Optional):

Ontario Dressage memberships are not required to enter. However, to be eligible for Ontario Dressage awards, you need to join Ontario Dressage by July 1st of the current year. Membership includes Ontario

Dressage newsletters and the ability to participate in Ontario Dressage awards and educational programs. Memberships can be obtained through Ontario Equestrian HORSEREG Portal.

CADORA Inc (Optional):

CADORA Inc memberships are not required to enter. To be eligible for National CADORA awards, you need to join CADORA INC by July 1st of the current year. Members receive an Omnibus Test Booklet, CADORA Ink newsletters and the ability to participate in CADORA's national awards and educational programs. Membership forms can be found on CADORA Inc's website at <http://www.cadora.ca/>

Western Style Dressage Association of Canada (WSDAC) (Optional):

WSDAC memberships are not required to enter the Western Style Dressage Tests. For more information about eligibility for WSDAC Awards, please see <https://westernstyledressage.ca/>

Dressage Niagara (Optional):

Note that Glanbrook CADORA members who are **also** a member in good standing with Dressage Niagara, and have shown in at least 2 Glanbrook CADORA in person shows may use scores from one (1) Dressage Niagara show towards Glanbrook Year End Awards (and vice-versa!). You must be a member of both clubs before your Dressage Niagara scores will count towards Glanbrook Cadora awards. Coaching:

EC Coach Status is required for all Canadian residents coaching athletes at EC-sanctioned competitions. Coaches who do not meet minimum Coach Status requirements at the time of competition may receive a fine as outlined in EC's Schedule of Fines & Penalties, and/or the horse/rider's points may be invalidated.

A **Licensed Coach Status** is required to coach at all EC-Sanctioned events. Registered Coaches may apply for a Single-Event Coach status upgrade at a cost of \$55 per event on a temporary

basis, while completing the requirements for Licensed Coach status. All Single Event Coach Status Upgrades must be done online in advance of the event.

- When registering for EC-sanctioned competitions, athletes must indicate the name of their coach on the entry form or specify that they are self-coached. Coaches from other countries, must be in good-standing with their home federation and must declare/have proof of insurance. See Rules of Equestrian Canada, Section A, General Regulations, Article 102, Safe Sport Environments. (A602.10)
- Athletes without a coach on-site can declare themselves as self-coached by providing their name and EC Sport Licence number on their entry form. Coaches that are not present at the event with the athlete are not to be listed on the entry form.

Biosecurity and Vaccinations



Biosecurity: All competitors must be aware of and observe procedures to prevent disease spread among horses on the show grounds. See [Biosecurity Requirements for All Competitors](#)

Biosecurity Requirements for All Competitors

Any horse exhibiting signs of illness must not be transported to the show. All horses must be temperature checked before travelling to the show. If the temperature exceeds 38.8 C the horse must not be transported to the show. At check in, you will be asked to report the temperature of the horse before transport.

General Biosecurity:

- Do not share feed/water containers or buckets between horses and do not use communal water troughs.
- While filling a bucket, do not let the hose end touch the bucket or the water in a bucket.
- Sharing tack and equipment puts horses at risk and is not recommended. If tack/equipment must be used by multiple horses, be sure to clean/disinfect it between uses by different horses.
- Observe good hygiene around all horses on the grounds, and especially after handling a teammate's horse prior to touching your horse.
- Wash hands immediately with soap and water, or use disinfectant hand solution after handling horses, especially after contact with the mouth, nose or feces.
- Please use hand sanitizers and indicate the importance of their use to your friends, family and casual visitors.
- Do not allow nose-to-nose contact between horses.

- Do not permit your horse to lick or sniff surfaces in common areas. If this does occur, please use a disinfectant wipe on the area.
- If your horse develops a fever or signs of illness, contact the show veterinarian or steward immediately.
- Following the competition, it is recommended that all horses be isolated at their home facility for 21 days prior to reintroduction to other horses. If this is not possible, be sure to observe all horses carefully for 21 days.
- Following the competition, all horses should have temperatures taken twice a day for four days, and be observed for abnormal behavior and signs of cough, nasal discharge, discomfort or lameness.
- In the event that a horse returning home following the horse show becomes sick PLEASE notify the Competition Organizer. This is a precautionary request in the unlikely event of a potentially contagious disease event.

Additional Biosecurity for horses stabled at the show:

- All stalls have been cleaned of all manure and bedding. You may sanitize your assigned stall prior to bringing your horse in.
- Stall Labels must be completed for each horse, including the horse name and 24-hour emergency contact information, and placed on the horse's stall door.
- You must check your horse's temperature twice a day and record it on the Horse Temperature Chart on the stall label. A normal horse temperature is between 37.2-38.3 C. Any temperature over 38.8 C (102 F) must be reported to the horse show office and/or horse show steward or veterinarian.
- If sharing a wheelbarrow, please do not bring it into your horse's stall. Leave it in the aisle.
- Please dispose of manure in designated areas only. Do not put trash in manure pile.

Vaccinations:

All horses attending Equestrian Canada sanctioned competitions must have met the requirements of A519, Vaccinations. See Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations. Vaccination certification must be submitted with entries. (A602.9)

ARTICLE A519 VACCINATIONS: All horses attending Equestrian Canada sanctioned competitions must have been administered Equine Influenza and Equine Herpes Virus (1&4) vaccinations within 6 months (+21 days grace period) before arrival at the event. No horse shall receive vaccination within 7 days prior to arrival at the event. Horses not in compliance with this rule may be asked to leave the event site at the discretion of Competition Management.

Equine Medication Control:

Any horse entered in any class at a competition may be selected for equine medication control testing while at the event location. (A602.5)

General Rules

2026 Equestrian Canada rules will apply. All exhibitors are responsible for knowing the 2026 Equestrian Canada rules (www.equestrian.ca).

Glanbrook CADORA will refuse entry to any EC member not in good standing. The show reserves the right to limit the number of entries due to time and to govern all conditions of the show.

Please be advised that failure to comply with the Glanbrook CADORA rules outlined in this prize list will result in disqualification and no refunds will be issued.

Judge's and Steward's decisions are final.

Neither Glanbrook CADORA, the show management and volunteers, show officials, property owners nor their employees will be in any way responsible for damage, injury or loss to persons, horses and other animals, or property of exhibitors or spectators.

Protective Headgear:

All athletes, regardless of age or level of competition, must wear properly fitted and fastened safety approved protective headgear including a chin strap (specified for equestrian sports) at all times when mounted at any EC-sanctioned Dressage or Para Dressage competition at the event location. Note: At the tack check that follows the test, the steward may ask the athlete to dismount so that the helmet can be inspected for safety standard labeling. (see Article E 4.0 Safety Headgear).

SECTION E GLOSSARY – HEADGEAR STANDARDS: Protective headgear must be certified under one of the following standards: ASTM (American Society for Testing Materials)/SEI (Safety Equipment Institute, Inc.); BSI/BS EN (British Standards Institution); EN (European Union Standards); AS/NZS (Australian/New Zealand Standards); or CE VG1 01.040 2014-12 (provided they are BSI Kitemarked).

Safety Vests:

Any athlete competing in an EC sanctioned dressage competition is permitted to wear a safety vest including an inflatable safety vest which attaches to the saddle. The vest must conform to the rules governing jacket colours (see Article E4.1 Safety Vests).

Return to Sport Rule:

Equestrian Canada has implemented a concussion-related policy, Article A101 Accidents & Return to Sport in the General Regulations. Glanbrook CADORA shows will follow all provisions of this policy.

Para-Equestrian:

Para-Equestrian classes will be governed by EC Para rules (Section E Dressage Rulebook).

Competition numbers:

Competition numbers must be worn or carried and be visible at all times by the horse or handler while the horse is outside of a stall on the show grounds for identification by the steward, or risk elimination from the show. See Articles A814. Riders are required to bring their own re-usable bridle/saddle numbers. A limited number of re-usable numbers will be available for purchase from the show office.

Tack Check:

Competitors in both Bronze and Silver competitions must present themselves to the Steward for a **tack check** after completing each test. It is the responsibility of the rider to check in with the Steward. Failure to do so will result in elimination. For more information on Tack Checks see Article E4.15.

Competition Ring:

Use of the competition ring area or inside the fenced area surrounding it is not permitted on competition day, other than during the competition test.

Warm-up:

A designated warm-up ring will be available at the show. Warm-up is not permitted in the competition ring or in the parking area during the show. Please only use the marked warm-up areas for mounted riding.

Hand-Walking and Lungeing:

Lungeing (unmounted) and work in hand may only be done by the athlete, owner, coach, groom or person responsible. (See Article E3.14.4)

Hand-walking is not permitted in the competition rings, in the fenced area surrounding the competition ring, or in the warm-up area on show day.

Lungeing is permitted in the warm-up area only before 7:30am (1 hour before the first scheduled test, whichever is later) when the warm-up area is open for mounted warm-up. Note that the show grounds open at 7:00am, and the warm-up area is unsupervised before the warm up area is open. After 7:30am, (or 1 hour before the first scheduled test if later), lungeing is permitted only in designated lungeing areas. It is not permitted to lunge a mounted horse at any competition site whether or not the horse is entered in the competition (See Article E3.14.5)

Test Callers:

If tests are called, it is the responsibility of the rider to arrange for a person to call the test. (See E9.1.1)

Caller's dress code:

Smart casual. Jeans, slacks, and mid length shorts are permitted. Tank tops, flip flops and sandals are not allowed. Inappropriately dressed callers may not be allowed to call a test (See E9.1.3)

Dogs:

Dogs should be kept in the trailer or stabling area whenever possible and must be leashed at all times. There will be a \$100 fee for any disruption to competition caused by a loose dog.

Open-toed shoes:

Open-toed shoes are not permitted to be worn by riders, grooms or handlers, coaches or test callers while on the competition grounds.

Stabling:

A limited number of stalls will be available for the show day on a first-come-first-served basis. Stalls may be accessed 90 minutes before the start of the competition and must be vacated shortly after the end of

the show. Stabling must be paid in advance with a refundable deposit for clean-out. Shavings must be ordered and paid for in advance, and there will be no additional shavings available for purchase on the day of the show. In case of a scratch, stabling fees may be refunded only at the discretion of the show manager. Stall bond deposit is refundable if stall is cleaned out by the end of the show day. Stall deposits will be retained should there be a stall clean out fee for your assigned stall charged by Ancaster Fairgrounds to Glanbrook CADORA. Competitors must provide their own stall cleaning equipment, and manure must be dumped in designated area.

Alternative and/or additional information on any competition will be included in the Glanbrook CADORA newsletter and posted on the Glanbrook CADORA website (www.glanbrookdressage.ca) and the FaceBook page – [Glanbrook CADORA](#).

Entry Information

- All entries must be submitted and paid for online through the CompeteEasy App www.competeeasy.com. The Glanbrook CADORA show will be listed and your entry can be completed and paid for according to the prompts.
- Entries are accepted on a first come first served basis until all available riding times are filled or up to the closing date, whichever comes first.
- Late entries (entries received and accepted after the closing date) will be charged a \$20 fee and will only be accepted if there is room. Entries accepted after the final ride times are posted will be subject to the \$20 late fee PLUS an additional \$30 last-minute fee (\$50 in total).
- Any changes or edits to an exiting entry after the closing date will be subjected to a \$10 change fee.
- The entry must be fully completed; incomplete entries will not be accepted.
- All conditions must be accepted by the Person Responsible, who is an adult EC Sport Licence holder who has, or shares responsibility for the care, training, custody, and performance of the horse and who has official responsibility for that horse under EC Rules. For an adult athlete, the PR shall be either the trainer, the owner or the competitor.
- A parent/guardian of a Junior competitor must complete and sign the **Parent/Guardian Waiver** document which can be found on Glanbrook CADORA's website [here](#), and is included in this prize list as **Appendix A**. The Waiver must be uploaded with the show entry or emailed directly to the show manager for the entry to be accepted. A parent/guardian is **not** required to have an EC Sport Licence provided they agree to abide by the rules and penalties contained in the Rule Book and acknowledge that they are liable under the penalty provisions of the Rules for any violations of the EC Rules by their minor child.
- Both owners and riders must be members in good standing with the EC and OE. Entries from Equestrian Canada Sport Licence holders that are deemed "*not in good standing*" will be refused.
- More than one athlete may ride the same horse/pony at a competition providing that the horse/pony is not entered by two athletes in the same class.

The maximum test per day restrictions also applies when competitions are running different levels of sanctioning at the same competition i.e. Bronze and Silver competition. If a horse was entered in both EC and WSDAC classes, the maximum number of tests would remain the same. Example - a horse/rider combo could do WSDAC test 1-3 as well as EC tests 1-1 and 2-1 for a total of 3 tests and 2 consecutive levels.

- Para-Dressage entries must provide a copy of classification documentation and Para Grade. Glanbrook CADORA does not have access to any special equipment, including mounting blocks or ramps, so please contact show management prior to entry to confirm accommodations can be met.
- Hors concours (non-competitive) entries may be accepted if space allows with permission of the show manager. Hors concours Entry will pay full entry fee and is subject to all EC rules but is not eligible for prizes, placings or awards. (See Article E.7.11.11).
- Schooling of non-competing horses is allowed on show day. The rider and owner must hold an EC Sport Licence and OE membership. Schooling entries must pay a \$25 schooling fee, and are subject to administration, late and change fees as applicable, and competition numbers must be worn or always carried and be visible by the horse or handler while on the show grounds. Schooling entries must complete an entry form, available at www.competeeasy.com, and will be subject to the same EC Rules as competitive entries while on the show grounds. They will not have access to the competition ring. (See Article E7.11.3).
- Substitution of horse or rider requests received after the closing date are at the discretion of the show manager.
- Cancellations may be made up until the closing date with a refund except for processing fees. After the closing date, a veterinary or medical certificate (on official letterhead) is required and entry fees (net of administration fees, processing fees, and any stabling fees) will be refunded upon notification by 6:00 PM on the Friday preceding the competition date. Contact: Alison Moeller, 905-580-1994. Presentation of a veterinary or medical certificate, on official letterhead, for illness or injury **must be made within 15 days after the competition in order to receive a refund**. Send the veterinary or medical certificate by email to: Glanbrook CADORA at glanbrookcadora@gmail.com.
- Cancellations made the day of the competition will forfeit the entries.** Glanbrook CADORA regrets that refunds cannot be issued for classes cancelled due to inclement weather conditions. If you are unable to compete for any reason, entry fees cannot be refunded. To help us to run our competitions effectively, please be courteous and notify the competition if you must cancel.

Fees

- Entry Fees for Glanbrook CADORA members after membership discounts are \$35 per class and \$30 per class for Junior riders. Entry Fees for non-members are \$40 per class and \$35 per class for Junior riders.
- ****NEW 2026** Junior riders who are Glanbrook CADORA members will receive an entry fee subsidy per show, up to \$100 split amongst the riders. Subsidies will be distributed post-closing date. (Note that entries must be received and accepted before the closing date to be eligible for the subsidy).**
- Entry Fees for Hors Concours entries are the same fees as regular competitive entries.
- Schooling Fee for non-competing entries is \$25 per horse.
- Drug testing fee per entry (\$4 for Bronze and \$8 for Silver).
- A \$25 Administration Fee per entry supports attendance of certified first aid service.
- A Dressage Levy of \$12 per entry supports EC dressage programs.
- A limited number of stalls will be available for \$50 per stall, plus a refundable deposit of \$50 for clean-out. Shavings may be ordered, but must be ordered and paid in advance with the show entry at a rate of \$10 per bag (shavings price subject to change). Additional shavings other than those that were ordered in advance will not be available for purchase.
- **A \$20 late fee** will be applied to any entry accepted but received after the **closing date**. An **additional \$30 last-minute late fee** will be added to entries accepted but received after the ride times are posted. Any changes to entry after the closing date will be subjected to a **\$10 change fee**.
- All Fees are paid through CompeteEasy. There will be a transaction fee of 5% of all fees, added to each invoice by CompeteEasy. The transaction fee is charged directly by CompeteEasy, and is non-refundable, even in the case of a scratch or if an entry is not accepted for any reason.

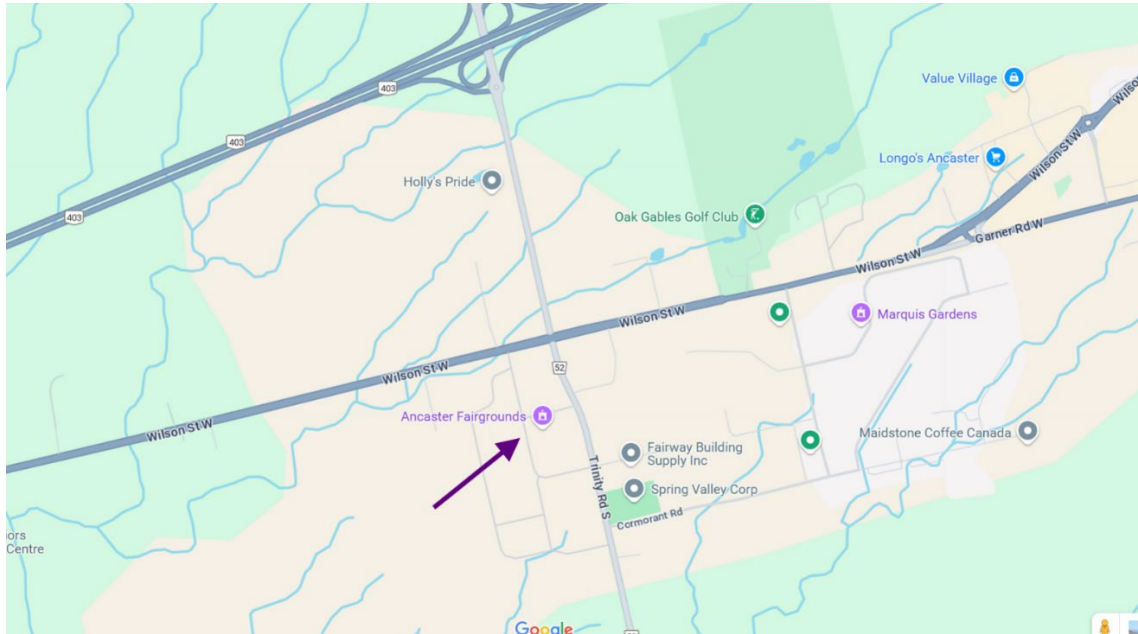

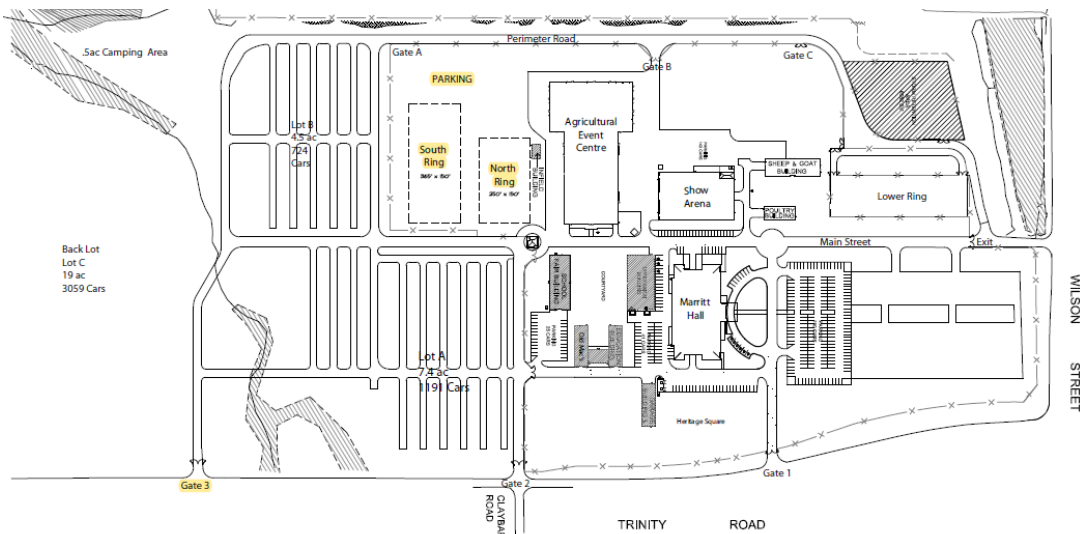

2. I am aware that there are inherent dangers, hazards and risks (collectively "Risks") associated with "Equine Activities" and injuries resulting from these "Risks" are a common occurrence.  - a. the propensity of any equine to behave in ways that may result in injury, harm or death to persons on or around them and to potentially collide with, bite or kick other animals, people or objects;
